Most notably, she works as the lead litigation counsel for the Cheyenne River Sioux Tribe in that tribe’s fight to stop the Dakota Access Pipeline, *Standing Rock Sioux Tribe, et al. v. US Army Corps of Engineers, et al.* No. 16-cv-1534 ( D.C. Cir. filed July 27, 2016).

Ms. Ducheneaux is honored to receive this recognition stating: “I am so lucky that I have been able to dedicate my legal practice to protecting tribal sovereignty and advancing the rights of Native people. As a Lakota woman and member of the Cheyenne River Sioux Tribe, my practice gives me the opportunity to carry on in the tradition of my ancestors who were warriors. I am fortunate to be able to fight for my people in state, tribal, and federal courts across the United States to protect my people who confront attacks on our tribal sovereignty and civil rights every day. I am honored to be recognized by Super Lawyers in this pursuit.”
